SUPPRESSIVE PERSON DECLARE
BRIAN MANDIGO

Brian Mandigo is hereby declared a Suppressive Person in accordance with HCO PL 23 December 1965RB, SUPPRESSIVE ACTS, SUPPRESSION OF SCIENTOLOGY AND SCIENTOLOGISTS.

" A SUPPRESSIVE PERSON or GROUP is one that actively seeks to suppress or damage Scientology or a Scientologist by suppressive acts." - LRH (HCO PL 23 Dec 65RB, SUPPRESSIVE ACTS, SUPPRESSION OF SCIENTOLOGY AND SCIENTOLOGISTS)

Brian Mandigo has on countless occasions stood outside of the Church of Scientology Washington DC, harassing Scientologists and non Scientologists alike. He has followed and stalked several women and posted videos of them despite being told they had a privacy right to not be in his videos.

He has accused the Church of practicing standard Scientology and has picketed publically against members of the Church.

In 2001, Brian Mandigo was denied training and processing until he agreed to cease out-ethics activities on the second dynamic.

Rather than ceasing out-ethics activities on the second dynamic, Brian left the church and started publicly attacking the church who was attempting to get his ethics in.

Brian has joined with others wearing a mask and protesting against Scientology in front of the Church.

There are many instances reported where Brian has encouraged people coming into or out of the Church to leave the Church. He has approached people in restaurants and started giving them unsolicited, alarming and entheta communications regarding Scientology and Scientologists. Despite being asked to leave, he has refused and has continued to harass people.

Brian has committed the following suppressive acts:

1. Any felony (such as murder, arson, etc.) against person or property.
2. Pronouncing Scientologists guilty of the practice of standard Scientology.
3. Public disavowal of Scientology or Scientologists in good standing with Scientology organizations.
4. Public statements against Scientology or Scientologists but not to Committees of Evidence duly convened.

5. Receiving money, favors or encouragement to suppress Scientology or Scientologists.
6. Calculated efforts to disrupt Church services or the flow of public up the Bridge through the Churches.

Any certificates or awards, Brian' may have been issued are hereby cancelled. Any benefits from trademark licensing or membership agreements he may have signed are also cancelled and he may not use the marks in any manner whatsoever.

Should it occur that Brian comes to his senses and recants, he is to do the steps A to E as described in HCO PL 23 December 1965RB, SUPPRESSIVE ACTS, SUPPRESSION OF SCIENTOLOGY AND SCIENTOLOGISTS.

His only terminal is the International Justice Chief via the Continental Justice Chief.
